References to the relevant harmonised standards used, including the date of the standard, or other technical specifications, including the date of the specification, in relation to which conformity is declared: **The AM3 FFP3 NR half mask for protection of the respiratory system against particles meets the requirements of the harmonised standard PN - EN 149:2001+A1:2009**

7. The notified body (Central Institute for Labour Protection - National Research Institute, ul. Czerniakowska 16, 00-701 Warszawa, unit number 1437) performed an EU type examination (module B) and issued an **EU type examination certificate No. UE/533/2021/1437 of 01.02.2021.**

The FFP2 filtering half mask as an individual protection means is subject to the procedure of evaluation of conformity with the type on the basis of internal production control and supervised product inspection at random intervals (**module C2**) under the surveillance of a notified body (Central Institute for Labour Protection - National Research Institute, ul. Czerniakowska 16, 00-701 Warszawa, unit number 1437)

9. The filtering half mask AM3 FFP3 NR fulfils the requirements included in §221 para. 1) and 2) of the Regulation of the Minister of Energy of 23 November 2016 on detailed requirements for the conduct of underground mining operations: "It is unacceptable to use in an explosive atmosphere personal protective equipment and work clothing and footwear which may: 1) be the source of an electric spark or arc, caused by static electricity or impact, 2) cause ignition of an explosive mixture" (Journal of Laws 2017, item 1118.)
